## Dear Governor Hochul:

As members of the Reform Jewish clergy in New York State, we write to request your immediate approval of the Climate Change Superfund Act.

Genesis 2:15 observes that, "The Eternal placed the human being into the Garden of Eden to work it and keep it." Those words emphasize our responsibility to protect the integrity of the environment so that its diverse species, including humans, can thrive.

Climate change is here – and is already harming our communities. Formerly considered once-in-a generation occurrences, the number of extreme weather events throughout New York State has increased dramatically over the past decade. We now live through frequent intense storms and heat waves. In 2022, Buffalo sustained a devastating blizzard that killed 47 people. Just one year earlier, Hurricane Ida killed 16 people and caused between \$7.5 and \$9 billion in damages. Between 2012 and 2023, New York experienced 16 federally declared Major Disasters from extreme weather events. The situation will undoubtedly get worse.

Your approval of the Climate Change Superfund Act will force the largest fossil fuel companies to cover some of the costs of preparing New York for extreme weather caused by climate change. Once signed, those fossil fuel companies will pay a total of \$75 billion--in \$3 billion annual increments over the course of 25 years--to fund infrastructure investments, including coastal wetlands restoration, storm water drainage system upgrades, and energy efficient cooling in buildings. At least 35% of all spending will go to historically disadvantaged communities. The companies will each pay a share of the total \$75 billion based upon their proportional contribution to overall emissions.

New York State taxpayers will benefit directly from the Climate Change Superfund Act because it will help ensure that less taxpayer spending is diverted to the costs of dealing with climate change. Last year alone, New York taxpayers footed a \$2.2 billion bill for the climate crisis.

Significantly, the companies most responsible for the fossil fuel emissions that cause climate change will not be able to pass to consumers the costs they incur under the Climate Change Superfund Act. That is the view of Joseph Stiglitz, Nobel Prize winner in Economics, the non-partisan Fiscal Policy Institute, and the Institute for Policy Integrity of the New York University School of Law.

For all these reasons, we urge you to sign the Climate Change Superfund Act immediately. Thank you in advance for your consideration of this important matter.
